This includes, but is not limited to any personal injury or disability the horse may receive while on OJAI VALLEY SCHOOL premises.

The OWNER fully understand that OJAI VALLEY SCHOOL does not carry any insurance on any horse(s) not owned by it for boarding or for any other purposes, and that all risks connected with boarding or for any other reason for which the horse(s) is in the possession on the premises of OJAI VALLEY SCHOOL, are to be borne by the OWNER.

F. HOLD HARMLESS:

OWNER agrees to hold OJAI VALLEY SCHOOL and its staff harmless from any claim resulting from damage or injury caused by said horse(s) to anyone and agrees to pay any legal fees, and/or legal expenses incurred by OJAI VALLEY SCHOOL in defense of such claims.

OWNER within fifteen days from the date OJAI VALLEY SCHOOL receives notice chorized, as OWNER'S agent, to arrange direct billing to OWNER. In the case ALLEY SCHOOL is/is not authorized by OWNER to arrange for such surgery.
