This AGREEMENT, dated _____, is made between OJAI VALLEY SCHOOL and _____, Owner of the below described horse(s), hereinafter referred to as "OWNER".

A. FEES AND TERM:

In consideration of \$_____ per horse per month paid by OWNER, OJAI VALLEY SCHOOL agrees to board the herein described horse(s) at the school stables, commencing _____ for a period of _____.

OJAI VALLEY SCHOOL agrees to provide adequate feed and facilities for normal and reasonable care required to maintain the health and wellbeing of the animal.

D. SPECIAL INSTRUCTIONS TO STABLE STAFF:

E. RISK OF LOSS:

During the time that the horse(s) is in the custody of OJAI VALLEY SCHOOL, OJAI VALLEY SCHOOL and its staff shall not be liable for any sickness, disease, estray, theft or death or injury which may be suffered by the horse(s) or any other cause of actions, whatsoever, arising out of or being connected in any way with the boarding of said horse(s). This includes, but is not limited to any personal injury or disability the horse may receive while on OJAI VALLEY SCHOOL premises.

The OWNER fully understand that OJAI VALLEY SCHOOL does not carry any insurance on any horse(s) not owned by it for boarding or for any other purposes, and that all risks connected with boarding or for any other reason for which the horse(s) is in the possession on the premises of OJAI VALLEY SCHOOL, are to be borne by the OWNER.

F. HOLD HARMLESS:

OWNER agrees to hold OJAI VALLEY SCHOOL and its staff harmless from any claim resulting from damage or injury caused by said horse(s) to anyone and agrees to pay any legal fees, and/or legal expenses incurred by OJAI VALLEY SCHOOL in defense of such claims.

G. EMERGENCY CARE:

OJAI VALLEY SCHOOL agrees to attempt to contact OWNER should its staff feel that medical treatment is needed for said horse(s), but, if OJAI VALLEY SCHOOL is unable to contact OWNER, OJAI VALLEY SCHOOL is then authorized to secure emergency, veterinary, and blacksmith care required for the health and well being of said horse(s). OWNER shall pay all costs of such care secured within fifteen days from the date OJAI VALLEY SCHOOL receives notice thereof, or OJAI VALLEY SCHOOL is authorized, as OWNER'S agent, to arrange direct billing to OWNER. In the case of emergency requiring surgery, OJAI VALLEY SCHOOL is/is not authorized by OWNER to arrange for such surgery.

H. SHOEING, WORMING, AND VACCINATION:

OJAI VALLEY SCHOOL agrees to provide the necessary shoeing, worming, and vaccinations of the horse(s) as is reasonably necessary; however, such expense for the same shall be the obligation of the OWNER.

I. OWNERSHIP:

OWNER warrants that he owns said horse(s) and that there are no liens against said horse(s), express or by law.

J. DEFAULT:

Either party may terminate this agreement for failures of the other party to meet any material terms of this contract agreement. In the case of any default by one party, the other party shall have the right to recover attorney fees and court costs incurred as a result of said default.

K. TERMINATION:

It is understood by the parties that pursuant to California State Law, the OJAI VALLEY SCHOOL has a lien on said horse(s) to secure payment for services to be provided by OJAI VALLEY SCHOOL hereunder, and that OJAI VALLEY SCHOOL shall have the right, without process of law to retain the said horse(s) until the amount of such indebtedness is discharged.

THIS AGREEMENT IS SUBJECT to the laws of the State of California.
